CANCELLATION BY SPONSOR: The Sponsor reserves the right to withdraw from this agreement no later than 60 days before the scheduled event by written notification to: Tracey Kretzer, 3070 South Woodrow Avenue, Arlington, Virginia 22206 **AND** via email to ParentChildU.com. Within a week of receipt of the Sponsor's notice of cancellation, the Speaker will refund 50 percent of the deposit paid at signing and return any airline tickets and other travel vouchers received.

CANCELLATION BY SPEAKER: The Speaker enters into this agreement in good faith, and honors commitments to speak on the requested topics on the scheduled date and at the agreed time. If a physician requires cancellation, the Speaker will refund all deposits paid and return any airline tickets and other travel vouchers received, constituting the limit of her liability within one week of such physician's notice. The Speaker is not responsible for weather; airline, taxi, or hotel strikes; accidents; and similar circumstances that prevent the Speaker from arriving at the event on time. The Speaker will phone the contact person upon leaving her home to travel to the event city, and phone again on arrival. The Speaker reserves the right to withdraw from this speaking engagement in the event that (1) the deposit due at signing, (2) the plane tickets, or (3) the hotel confirmation (where applicable) has/have not been received 30 days in advance of the event date and as a result, the Sponsor forfeits the 50 percent of the Speaker's fee signing deposit as the limit of its liability.
